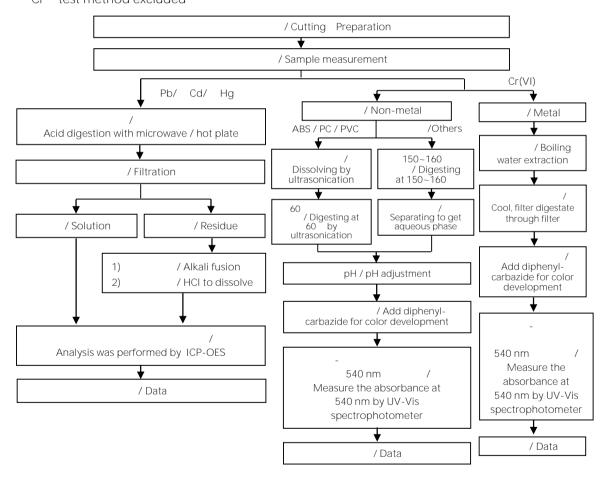

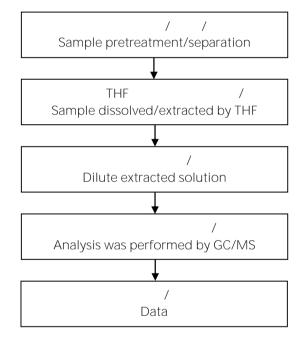

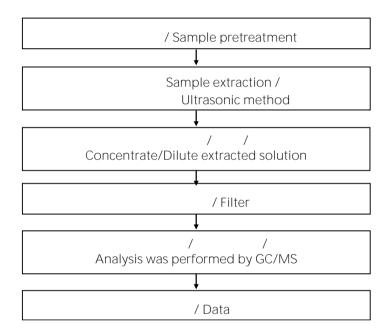

#### / Analytical flow chart - HBCDD





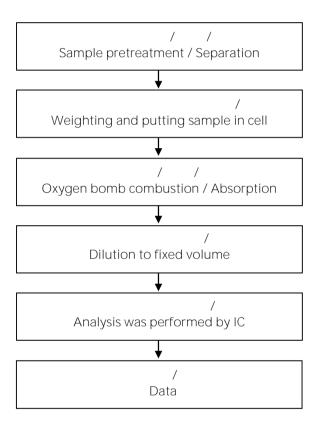

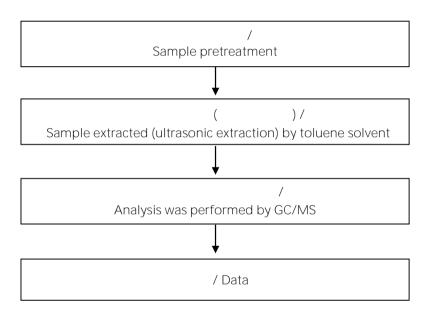

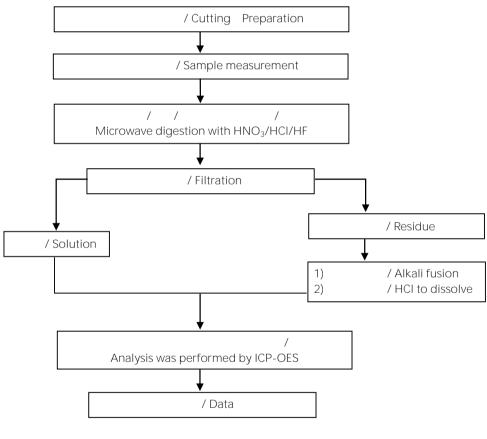
