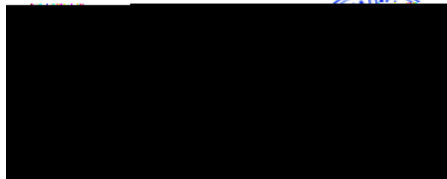

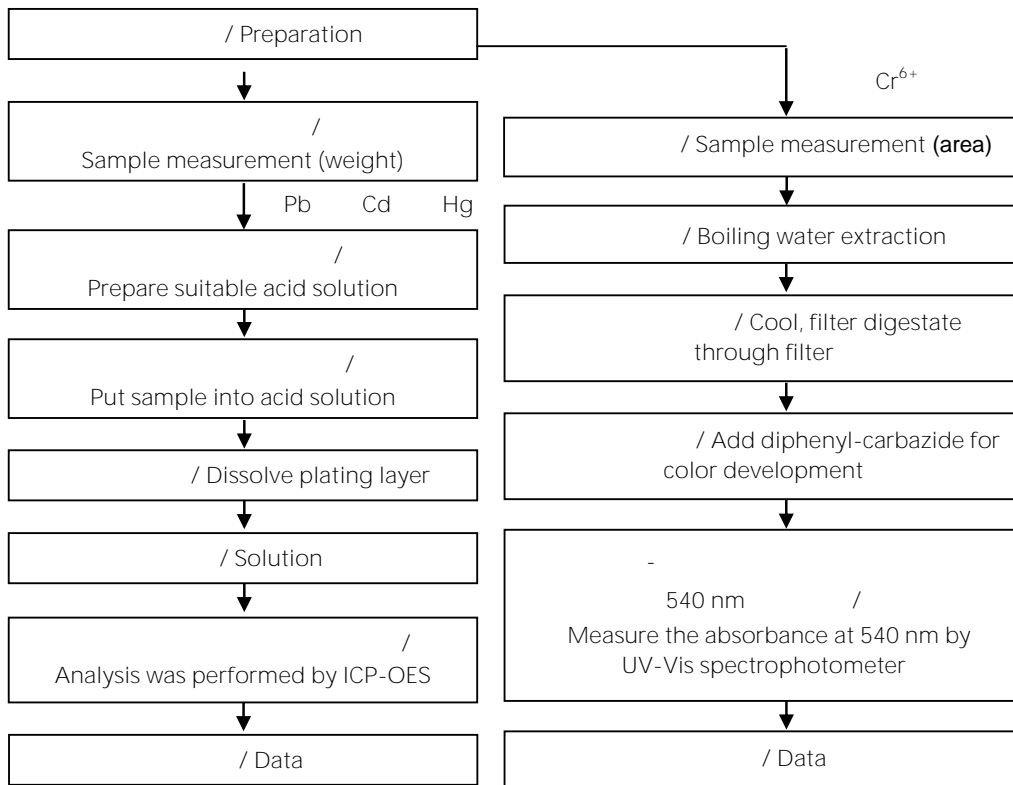

/ Flow chart of stripping method for metal analysis

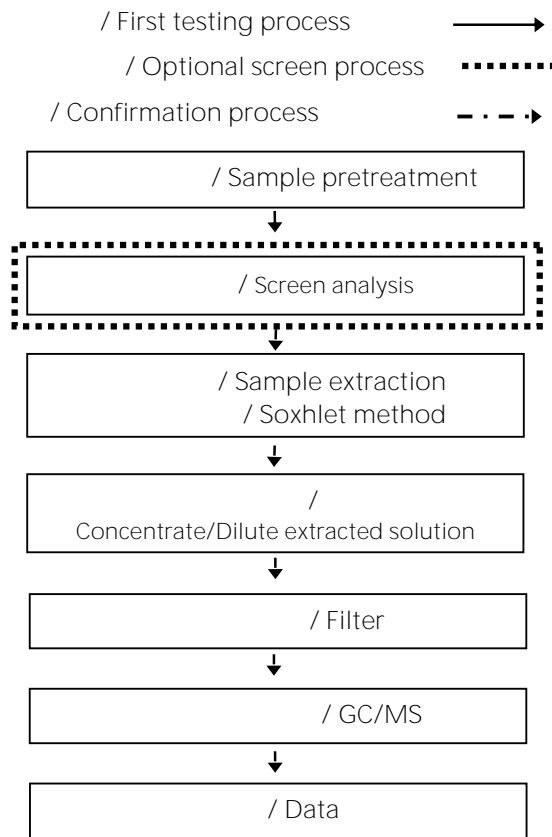

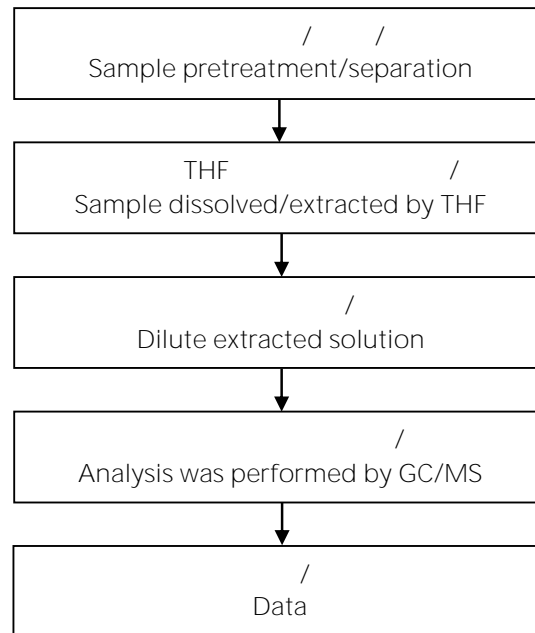

/ Analytical flow chart - Phthalate

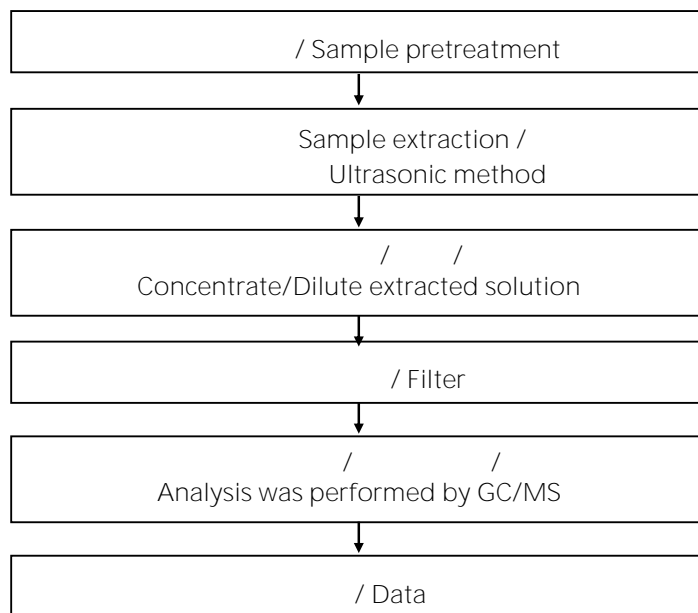

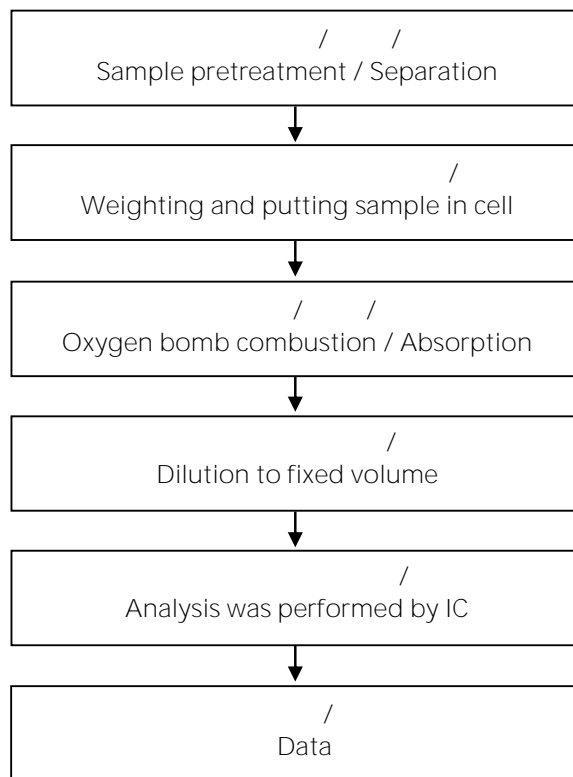
/ Analytical flow chart - HBCDD

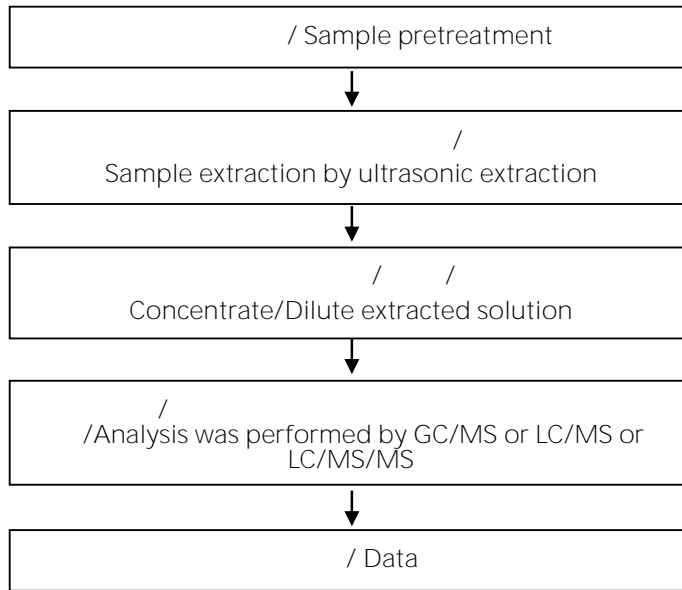
/ Analytical flow chart - Halogen

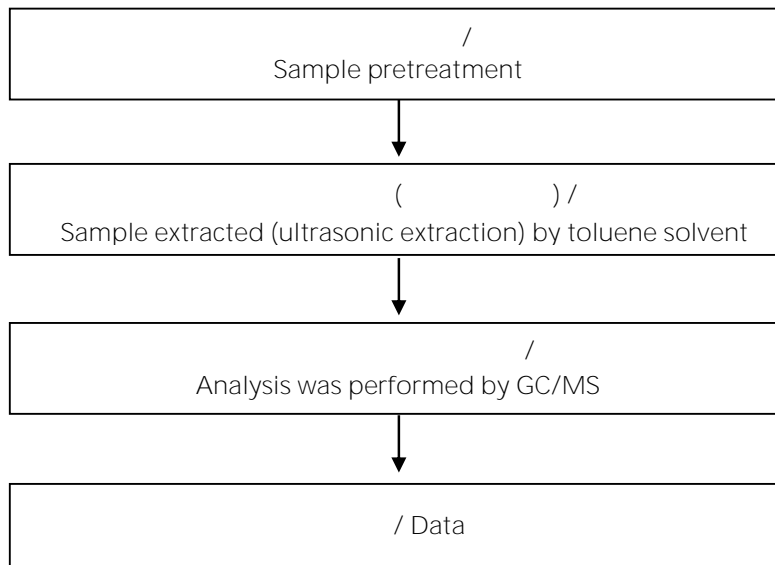

Analytical flow chart - PAHs (Polycyclic Aromatic Hydrocarbons)



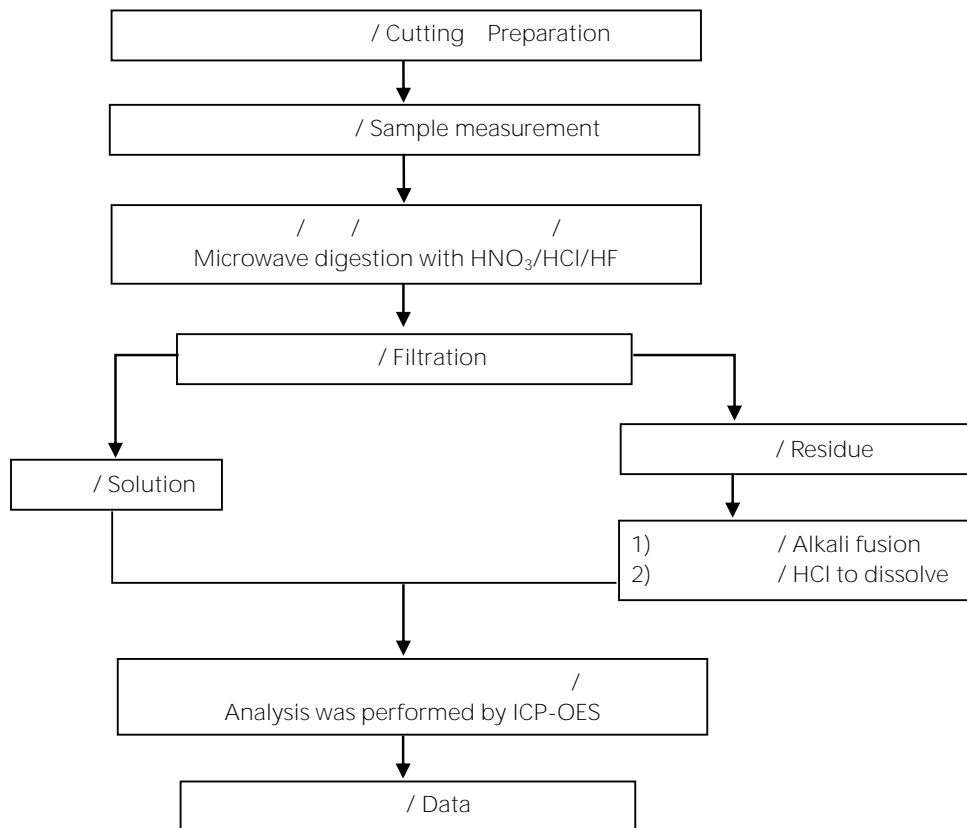

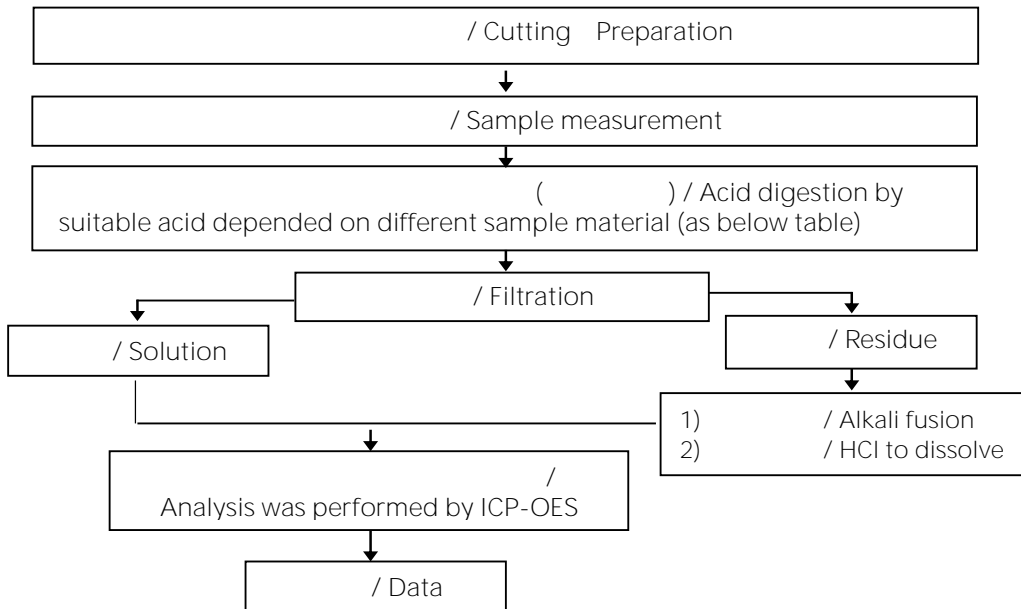

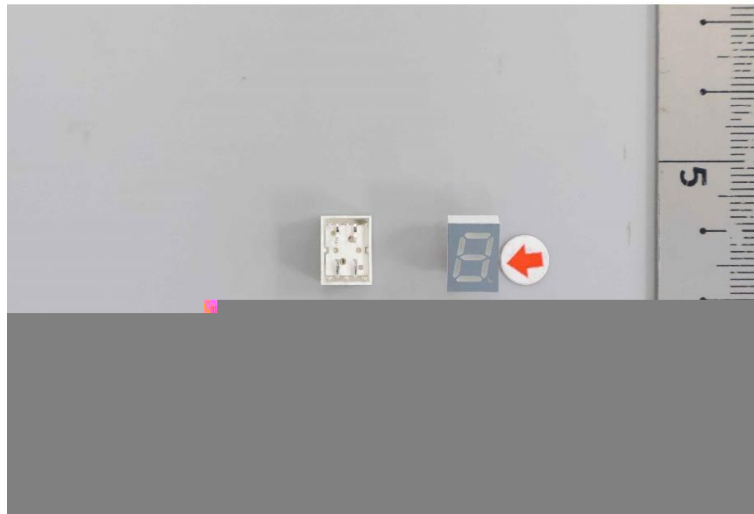
